The Huron County Library Board met in the Court House Council Chambers, in Goderich on October 20<sup>th</sup>, 2010. All members of the Board were present except for Members N. Fairles and P. Menzies. Chair G. Robertson called the meeting to order at 9:00 a.m.

The Book Expenditure and Outstanding Book Order Report for the period ending September 30<sup>th</sup>, 2010 which showed total purchases to date of \$303,588 with outstanding orders totalling \$74,248, leaving the approximate amount in the uncommitted book budget of \$100,324.
