The purpose and effect of this application is to re-designate the subject lands from Recreational to Recreational Exeter Golf Course Special Policy Area to permit development of seven lots for future residential use. The subject lands are approximately 0.6 acres each with frontage on Morrison Line ranging from 38 to 42 metres. This Official Plan Amendment is considered disputed as it is not consistent with the Provincial Policy Statement, and does not conform to the Huron County and South Huron Official Plans. Formal objections were also received from a neighbour with concern on the application. The Municipality of South Huron Council has adopted Official Plan Amendment No. 14 and forwarded to the County for approval.
