6.1 Update from the Transition Committee – Tanya Sangster reviewed an update from MOH Miriam Klassen.

After a long partial pause, during which program work continued but many other work streams cut back drastically, we finally received clear direction from the Ministry to proceed with a full merger and we also received budget confirmation. Since that time, here is what has been accomplished:

- Program Subcommittees completed CSA and FSM with recommendations to the PWG
- PWG completed the next draft of the Org Chart, which goes all the way to the frontline staff level
  - 2 Manager positions have been filled internally from a pool of great candidates, Wade Sanford has accepted the IT Specialist position as a 6 month secondment (to be reevaluated at that time), Christina Taylor has accepted the appointment of Privacy Officer, Jennifer Duffin has accepted the appointment of CNO HPPH will be well supported by these roles.
- The Foundations team created an Operational Planning/Program Planning tool and teams have been getting together to develop HPPH program plans for 2020
- The Management Team has determined the program structure for the ASP and are prepared to submit a HPPH ASP for 2020
- A joint HPPH 2020 budget which will be previewed by both boards in 2019, and approved by the new board in 2020
- The non-union compensation package has been prepared for Board approval during their first meeting January 2, 2020
- The new logo has been developed
- A new domain name has been secured
- The new website content has been created
- A non-disclosure agreement and a data sharing agreement have been signed
- Payroll and accounting data have been extracted from HCHU in preparation for the new organization
- An IT plan has been developed to ensure hardware and software transition
- New technology has been installed or will be installed across sites by Dec 30th
- A plan has been developed for the intranet ready for launch for January 01 (WAVE)
- The obligated municipalities have been invited to appoint new board members, who will attend their first board meeting January 2 in Clinton

- We will enter our HPPH offices in 2020, our computers/phones/keycards/FOBs will work; if not, we will continue our work in other ways until the IT team can fix the issues
- Finally, we can all get back to the work of Public Health!
