# Background

#### Office Closure

## Financial Support Available through Huron County Social Services

The unfortunate reality of today is that COVID-19 is resulting in many people dealing with financial hardship.

If you are a resident of Huron County (not a visitor or tourist), and require financial supports you might qualify for benefits.

Benefits and services available through Huron County Social Services include:

- 1. Emergency Assistance
- 2. Ontario Works Financial Assistance
- 3. COVID-19 Emergency Benefit
- 4. Pathways to Self-Sufficiency
- 5. Discretionary Benefits
- 6. United Way Perth-Huron COVID-19 Urgent Needs Fund
- 7. Low-income Energy Assistance Program (LEAP) ERTH Power Customers

### **Emergency Assistance**

If you need help paying for food and housing and are not already on Ontario Works or ODSP, you can apply for COVID-19 emergency assistance.

You may qualify if you live in Ontario (not a visitor or tourist), are in a crisis or emergency situation, and do not have enough money for things like food and housing. For example, a crisis or emergency

includes situations where you:

- have been affected by COVID-19
- are being evicted from your home
- are in or are leaving an abusive relationship
- are worried about your safety

If you are eligible for emergency assistance, the amount you get will depend on your specific situation. For example, you may get:

- approximately \$733 for a month if you are a single person and need help paying for food and shelter
- more if you have children
- up to 48 days of support depending on your specific situation

#### **Ontario Works Financial Assistance**

Ontario Works provides money for food, shelter and other costs to people in financial need who meet the eligibility criteria.

Financial Assistance may include money for food, shelter, clothing and other household costs, the cost of prescription medications, and other help with health costs.

The monthly amount of assistance someone can receive from Ontario Works depends on family size, housing costs and income.

To qualify for Ontario Works assistance in Huron County you must be:

- living in Huron County (not a tourist or visitor)
- aged 18 or over (16/17 if special circumstances exist, such as abuse or if there is no home/ financial support available)
- in financial need (your household doesn't have enough money to meet basic living expenses)

The requirement to be willing to make reasonable efforts to find, get ready for or keep a job (unless you have medical or special circumstances that stop you from being able to do so) has been temporarily waived due to COVID-19.

During the COVID-19 pandemic applications for financial assistance can be completed over the phone and verified through third party checks, original documents and wet signatures are not required at this time. Documents will need to be provided at a later date.

#### Reapplying for Ontario Works Financial Assistance

If you were receiving Ontario Works benefits in Huron County and your file was closed within the past 12 months contact Huron County Social Services at 519-482-8505 or 1-888-371-5718 ext. 4501.

You will be asked to provide information about your current situation. Information will be verified by third party checks. Original documents and wet signatures are not required at this time but will need to be provided at a later date.

Clients are still expected to report all income as usual. If the time period overlaps, for Federal Assistance and Ontario Works Assistance overpayments, a recovery will result.

#### **COVID-19 Emergency Benefit for Current Social Assistance Clients**

Assistance is available for those currently receiving social assistance who are facing additional costs related to the COVID-19 outbreak. This funding can be used to meet a broad range of needs, for example: cleaning supplies, transportation, food or clothing that individuals and families may require due to COVID-19.

Emergency benefits for COVID-19 related expenses are the same for both programs: up to \$100 for single individuals and up to \$200 for families.

### Pathways to Self-Sufficiency

Pathways to Self-Sufficiency is an emergency program that helps low-income families and individuals in Huron County when they are most in need. The aim of the program is to reduce child poverty, promote attachment to the workforce, and prevent homelessness. All items require preapproval by Huron County Ontario Works staff.

Financial assistance may also be subject to funding and frequency limits and may be based on the number of people in your family unit.

Pathways to Self-Sufficiency is not available for those currently receiving social assistance.

## **Discretionary Benefits**

If you are in receipt of social assistance in Huron County you might be eligible for Discretionary Benefits. The Discretionary Benefits Program provides financial assistance to purchase essential health related and emergency assistance items when all other resources are exhausted. All items

require pre-approval by Huron County Ontario Works staff.

Typical items covered under Discretionary Benefits include:

- One-time health related items such as eyeglasses, emergency dental treatment, prosthetics and health related supplies.
- Non-health related items such as costs associated with maintaining or obtaining housing.
- Costs associated with funerals, burials and cremations.

Financial assistance may also be subject to funding and frequency limits and may be based on the number of people in your family unit.

## United Way Perth-Huron COVID-19 Urgent Needs Fund

COVID-19 is putting our community's most vulnerable people in an extremely challenging situation. Many do not have the support if they need to self-isolate. Those who already face significant barriers, including poverty, homelessness and social isolation, need even more of our help during this time.

The County of Huron is working with the United Way Perth Huron to disperse funds through the COVID-19 Urgent Needs Fund to the low-income residents of Huron County.

# Where can I find information about my Ontario Works case?

Find out about your payment status and details, view your letters, and report income and address changes online through www.ontario.ca/MyBenefits. It's secure, easy to use and available 24/7 from your smart phone, tablet or computer.

## How will I receive payment?

Clients who have bank accounts are strongly encouraged to sign up for direct deposit. To find out how, call 519-482-8505 or 1-888-371-5718 ext. 4501. Cheques may be available under limited circumstances.

# Are Ontario Works Financial Assistance and Emergency Assistance taxable benefits?

Yes these benefits are taxable. A T5007 will be issued.

# Are there any supports to help me pay my electric and natural gas bills?

There are two programs to help lower-income customers with their bills:

#### 1. Ontario Electricity Support Program (OESP)

This program provides ongoing help to low-income customers with a monthly on-bill credit to reduce their electricity bill.

### 2. Low-income Energy Assistance Program (LEAP)

This program provides a one-time grant towards your electricity or natural gas bill if you are behind on your bill and may face having your service shut off, it is for emergency situations.
