

## NOTICE OF PUBLIC OPEN HOUSE AND PUBLIC MEETING

Concerning a Proposed Official Plan Amendment for a Five-Year Review of the Huron County Official Plan

**TAKE NOTICE** that the Council of the Corporation of the County of Huron will hold the following Public Open House and Public Meeting by electronic means and teleconference:

Special Session of Huron County Council – Electronic Public Open House on March 30<sup>th</sup>, 2021 at 7:00 p.m. This final Open House is to review and discuss the proposed amendments to the Huron County Official Plan as part of a 5-Year Review of the Plan.

**Electronic Public Meeting on April 7<sup>th</sup>, 2021 at 9:00 a.m.** to consider a proposed official plan amendment affecting all lands in the County of Huron, being a 5-Year Review under Sections 17 & 26 of the Planning Act.

**ANY PERSON** may attend the public meeting by electronic means and teleconference and/or make written or verbal representation either in support of or in opposition to the proposed official plan amendment.

**IF YOU WISH TO BE NOTIFIED** of the adoption of the proposed official plan amendment, you must make a written request to Susan Cronin, Clerk, County of Huron, 1 Court House Square, Goderich, ON, N7A 1M2.

Following Council's adoption of the official plan amendment it will then be sent on to the Province for their review and approval. The Ministry of Municipal Affairs and Housing is the approval authority for an official plan amendment for a 5-Year Review of the Huron County Official Plan. Pursuant to subsections 17(36.5) and (38.1) of the Planning Act, the decision of the Ministry is final and not subject to appeal.

The Plan is a forward-looking document that includes vision, goals and policy directions for development of the County for Agriculture, Community Services, the Economy, Extractive Resources, Natural Environment, and Settlement Patterns over the next 25 years.
