

- Preventing Homelessness
- Ending Homeless
- Increased Access to Affordable Housing and Housing Supports

The nine strategic areas to fulfill these goals:

- 1. Establish a Framework to Provide Leadership, Governance and Advocacy
- 2. Expand Access to Affordable Housing
- 3. Improve Data Collection and Reporting
- 4. Develop and Emergency Service System Oriented Toward Ending Homelessness
- 5. Increased Targeted Efforts to Prevent Homelessness
- 6. Improve Service Coordination
- 7. Use Municipal Tools to Facilitate Affordable Housing
- 8. Preserve and Improve Existing Social Housing
- 9. Establish a People-Centered System of Housing and Homelessness





Affordable housing is part of the basic infrastructure of the community, much like water and sewage services and roads, or policing and medical services. Housing is the foundation that enables people to be able to stay safe and healthy and to be able to find employment or attend school.



Over time, the Community Housing Renewal Strategy will help Ontarians be more connected to housing assistance and supports that better meet their needs, live in safer and well-maintained buildings, find housing more easily, and have more opportunities to participate in the economy and their community.

The Community Housing Renewal Strategy is complemented by the Housing Supply Action Plan, which is focused on enhancing housing in the broader housing market. Creating more housing, of the types and sizes people need, will help make home ownership and renting more affordable and give people more choice.

Together, Ontario's Community Housing Renewal Strategy and the Housing Supply Action Plan demonstrate the government's commitment to supporting the creation of housing that responds to all Ontarians' needs, across all incomes.

Ontario Renovates:


- Combination Smoke/Carbon Monoxide Detectors in 84 Community Housing Family Units

- Electrical upgrade at Seniors Building at 45 Alfred Street in Wingham
- 5 Private home Ontario Renovates projects

Housing Allowance:

 Housing Allowances are a monthly subsidy to assist with rental costs to make housing costs more affordable and sustainable. OPHI Funding provided assistance to a further 6 Seniors and 2 persons with disabilities in our community.

Huron County as well received further funding in the Investment in Affordable Housing Extension Program. With this funding, the following assistance was provided to those living in our community.




