(C/O Floral Becker-Morton)(Applicant), Part Lot 9 & 10, Part Lot 26 & 27 with ROW, Plan 192, Subject to easements, Brussels Ward, Municipality of Huron East (presented by Shae Stoll)

The purpose of the applications is to create a new lot to be used for a parking lot for the Brussels Four Winds event barn. There are two concurrent applications being considered to create the new lot, C11-2024 and C12-2024. It is proposed that the severed lands from application C11-2024 will merge with the severed lands from application C12-2024 to create one parcel of land approximately 1230 square metres in size. Both severed parcels are currently used as a parking lot. The applications also propose to create various rights-or way/easements for access and parking to the rear of the commercial buildings on the retained lands as well as blanket easements for Municipal services and stormwater drainage. The applications conform to the Huron East and Huron County Official Plans and are consistent with the Provincial Policy Statement, 2020. A neighbour has submitted correspondence objecting to the proposed severances due to concerns over the impact to their property and parking as well as due to an ongoing unrelated legal dispute between themselves and the owner of the lands to be severed. The Municipality of Huron East has recommended that the applications be approved, and the Planning and Development Department recommends the applications be approved with conditions.

This application proposes to create an approximately 475 square metre (5,113 square feet), vacant infill residential lot on this corner property with an approximately 1,146 square metre (12,330 square feet) retained parcel. This is a disputed consent application due to neighbours' concerns regarding lot drainage, lot size, tree loss, traffic safety, and construction impacts. The application is consistent with the Provincial Policy Statement and conforms to the Huron County and Central Huron Official Plans. Both the Municipality of Central Huron and the Department are recommending approval with conditions.
