BY-LAW NO. 2020-072

**A BY-LAW OF THE CORPORATION OF THE COUNTY OF HURON
TO APPOINT MEMBERS TO VARIOUS COMMITTEES AND BOARDS.**

WHEREAS pursuant to *The Public Transportation and Highway Improvement Act, R.S.O. 1990, c. P.50*; *The Health Protection and Promotion Act, R.S.O. 1990, c. H.7*; *The Homes for the Aged and Rest Homes Act, R.S.O. 1990, c. H13*; *The Public Libraries Act, R.S.O. 1990, c. P.44*; *The Planning Act, R.S.O. 1990, c. P.13* and *The Municipal Act, 2001, S.O. 2001, c. 25* and County of Huron By-law No. 2018-067; it is deemed necessary and expedient to make appointments to various Boards and Committees;

AND WHEREAS the Council of the Corporation of the County of Huron deems it expedient to appoint persons to provide for and assist in the administration, protection and management of the County;

AND FURTHER THAT the appointments of citizens and members of Council to all other Committees be as follows and shall remain in effect until replacement appointments are made by By-Law;
